QBEC: Claudia stated that Keyhole security is scheduled for October to install the new camera system as well as Rising Sun to do the fall hedging. **POWER AND WATER PROJECTS:** Commissioner Kuest stated we have received a revised scope of work from Landau regarding the water treatment after discussion upon motion by Commissioner Kuest seconded by Commissioner Connelly, tasks one through four were approved.

**PORT PROTECTIVE SERVICE:** Dan stated that they are done with Cresent bar for the season. Desert Aire is going well working seven days a week and Angel is handling George.

**INDUSTRIAL PARK 5**: Mr. Woodkey met with Capstone to complete the punch list on the water main extension. Mr. Woodkey is also working on the binding site plan.

**KER PROPERTY:** Mr. Woodkey stated the binding site plan has been updated and he will get it to the City of Quincy next week.

**AIRPORT:** Commissioner Connelly stated the advertisements for bids will be posted on 9/17 and 9/24.

**EDC:** Commissioner Morris stated the group meeting is scheduled for November 5<sup>th</sup>.
