

The 1,235th MEETING of the Port District No. 1 of Grant County was held at the Port District office at 101 F Street SW on **Wednesday, June 24, 2026.**

Commissioner Pat Connelly called the meeting to order at 4:00 p.m. Present were Commissioner Brian Kuest, Dahlia De La Rosa, Claudia Garcia, Gabe Porter, District Fire Chief David Durfee, Frank Gonzales and Danna DalPorto.

Notice of Publication: Comprehensive Scheme of Harbor Improvements: Commissioner Connelly open the public meeting for comments Danna DalPorto asked if the Port still owns Bishop and where the Port gets the water for the golf course. Commissioner Connelly stated we have sold Bishop and we buy M&I water for the golf course. Without any more public comments and motion by Commissioner Kuest, seconded by Commissioner Connelly Resolution 2026-05 Amending the Comprehensive Scheme of Harbor Improvements was approved as printed.

QBEC: Claudia reported that Gavin has graded the gravel parking lot and sprayed the weeds and finished washing all the tables. Commissioner Connelly stated that Ty came out to check the sound system in the main hall and will be providing us with a quote to replace the sound board in the main hall he is estimating around \$1,200 not including labor upon motion by Commissioner Kuest seconded by Commissioner Connelly the approval of up to \$1,800 plus installation and taxes to upgrade the sound board in the main hall was approved. Ty will provide us with a quote to install visual and audio conferencing in the Board room.
